**WHEREAS**, Ravenna Township participated in the preparation of the 15-community Dakota County Rural Collaborative 2030 Comprehensive Plan Update; and

**WHEREAS**, the *Dakota County Rural Collaborative Comprehensive Plan* was forwarded to adjacent communities, area school districts, Dakota County, the Vermillion River Watershed Joint Powers Organization (VRWJPO), and the North Cannon River Watershed Management Organization (NCRWMO) for six-month review on June 27, 2008; and

**WHEREAS**, the *Dakota County Rural Collaborative Comprehensive Plan* was forwarded to the Metropolitan Council for formal review on December 31, 2008; and

**WHEREAS**, the Metropolitan Council found the *Dakota County Rural Collaborative Comprehensive Plan* consistent with regional growth plans on July 24, 2009; and

**WHEREAS**, an *Addendum* to the *Dakota County Rural Collaborative Comprehensive Plan* for Ravenna Township has been prepared which contains mapping, demographics, forecasts, and land use data unique to Ravenna Township.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of Ravenna Township approves the *Dakota County Rural Collaborative Comprehensive Plan* and *Addendum*.

**BE IT FURTHER RESOLVED** that the Board of Supervisors of Ravenna Township approves the *Summary for Publication* for the *Dakota County Rural Collaborative Comprehensive Plan* and *Addendum* and authorizes its publication in the Official Newspaper.
