

Ravenna Township, Dakota County

1. Supervisor, Mike Waxon, called the Board of Canvass Meeting to order at 7:00 p.m. Supervisors, Carl Reuter and Brian Riches and clerk/treasurer Caroline Spurgeon were present.
2. Carl moved to approve the agenda. Brian seconded; motion passed unanimously.
3. The purpose of the meeting was to canvass and certify the town's election results for the year 2016.
4. The election judges had signed and sealed the election ballots and the election summary sheets into the various envelopes in accordance to state law.
5. There were no absentee ballots; therefore no Absentee Ballot Board Envelope C (yellow) was available. Absentee Ballots – Dominion Voting document and the Polling Place City/Township Envelope C (blue) were used for the Board of Canvass.
6. Caroline Spurgeon explained that all absentee ballots are handled by the Absentee Ballot Board at Dakota County. Dakota County provided Caroline the Absentee Ballots – Dominion Voting document showing that our township had no absentee ballots.
7. Head Election Judge, Brenda Johnson provided sealed Envelope C (blue) to Caroline after the elections. Caroline handed the sealed and signed envelope to Mike. Mike opened the envelope and removed the summary tape, Precinct Summary Statement Worksheet, Precinct Equipment and Ballot Certification, Precinct Official Certification/Election Judge Oath and the Precinct Write-In Tally Form.
8. Mike read the following from the precinct statistics worksheet and summary tape that was submitted and signed by the election judges:
